Circular núm. 14.

En la provincia de Leon se ha levantado una partida carlista que, perseguida por la Guardia civil, huye en direccion á los montes de Asturias. Tropas del Ejército marchan tambien en su busca, y es de esperar que muy pronto sea alcanzada y deshecha como lo han sido las de la Mancha.

Abrigo la esperanza de que en esta provincia no han de encontrar eco las sugerencias de los fanáticos secuaces del obscurantismo; pero por si algunos incautos, ignorantes ó perdidos respondiesen á ellas, y para el caso en que de otras partes viniesen al territorio perturbadores de la paz que en el mismo se disfruta, encargo á los señores Alcaldes que redoblen su vigilancia y estén preparados para cumplir cuanto les previne en mi circular número 9, inserta en el *Boletin oficial* de 26 del corriente, entendiendo que los partes por ella exigidos me los habrán de comunicar inmediatamente por telégrafo, donde le haya, ó de la manera mas pronta posible, á fin de adoptar con la propia urgencia las disposiciones que requiera el servicio.

Repito el final de la citada circular. Asi como suplicaré al Gobierno conceda las debidas recompensas á los que se distingan por sus actos de valor, energía y patriotismo, estoy resuelto á exigir sin contemplacion alguna á los Alcaldes y demás funcionarios públicos la responsabilidad en que incurran por falta de celo en el cumplimiento de sus deberes.
